### 2. ADOPTION OF AGENDA

Motioned by Bill Threlkel to adopt the agenda. Seconded by Carla Sutton. THE MOTION PASSED.

3. **PUBLIC FORUM -** Any member of the public may address the Irrigation Committee on any matter within the jurisdictional authority of the Irrigation Committee. Public members desiring to provide comments, must be recognized by the Committee Chairman.

Comments must be directed only to the Irrigation Committee. The Irrigation Committee will hear communications on matters not on the agenda, but no action will be taken. No disruptive conduct shall be permitted at any Irrigation Committee meeting. Persistence in disruptive conduct shall be grounds for summary termination, by the Chairman, of that person's privilege of address.

Bonnie Neeley asked if the committee could meet at an earlier time and not during the dinner hour. Mr. Griffiths said this would be discussed under Old Business.

## 4. APPROVAL OF MINUTES

Motioned by Bill Threlkel to approve the minutes of May 19, 2022. Seconded by Carla Sutton.

#### 6. OLD BUSINESS

# A. Review Draft of Irrigation Committee Policy

There were no recommended changes to the draft irrigation committee policy.

## B. Establish Regular Meeting Time

The committee discussed when and how often to hold Irrigation Committee meetings.

Motioned by Carla Sutton to meet monthly during the irrigation season, and as needed during the off season (Feb, Mar, Apr, May, Jun, Jul, Aug, Sept, Nov) with the meeting time to be determined. Seconded by Bill Threlkel.

The Motion Passed.

### C. Discuss Possible Adjustment to Season

Kristy McKay brought up the water restriction mandate and asked, under Section 3 Distribution of Water, whether a device could be used to reduce water per customer to meet the mandate, but allow water to continue to flow until the regular end of the season.

The Committee discussed ways to reduce water now to keep irrigation water flowing until the end of the season and explore all possible ideas, including, but not limited to voluntary reduction or other possibilities.

Kristy volunteered to draft a proposal to present to the Board.

Motioned by Ray Griffiths to draft a proposal for the board. Seconded by Bill Threlkel.

The Motion Passed.

# A. Review material customers currently get
