The District invites interested customers to apply for public member positions on the Finance Committee and the Irrigation Committee.

The **Finance Committee** will soon be participating in the FY 2022-2023 budget review process and hopes to fill the four openings on the committee. Interested persons are invited to submit their application by March 1, 2022.

The primary role of the Finance Committee is to assist the Board in the review of District financial information and to make recommendations to the Board on matters related to the District’s finances and budget. The committee, an advisory body, reports to the Board and meets at least monthly. The Committee members include Steve Miller (Chair), Marilyn Boehnke, and Andy Fisher. The Board Liaison members are Treasurer Mike Thornbrough and Vice President Mitch MacDonald.

The **Irrigation Committee** was recently established by the Board to advise them on matters related to irrigation service. The application process for irrigation service has been initiated in preparation for the start of irrigation season in May. The public member positions need to be filled by the March Board meeting. The Directors appointed to the Committee are Donna Seaman (Chair) and Gerry Stewart. Interested irrigation customers are invited to apply by March 1, 2022.
